The landscaped grounds **are dominated by an ornamental garden with fruit trees and herbs** (pear, cherry, apricot, currant, raspberry, blueberry, sage, lemon balm, mint, marjoram and others) and **a terrace with access to a heated and illuminated swimming pool with automatic regulation**.

The villa also has a **garden house of 20.3 m²** with a separate kitchenette and toilet.

Parking is provided in a **garage of 72 m² for 3 cars** with the possibility of parking additional cars in front of the garage and under the carport. The construction took into account modern and timeless elements with an emphasis on energy efficiency. The villa is characterised by a high standard of finishes and fixtures and fittings.

The ground floor of the family villa consists of the main entrance to the hall, bathroom with toilet, separate room with access to the kitchen and dining area with access to the terrace, common room, separate room that can also be used as a separate room with access to the terrace (156, 85 m²)

The first floor (the night part of the family villa) consists of a master bedroom with its own bathroom with a bathroom, bathtub, toilet, two separate rooms, a bathroom belonging to the rooms, a separate toilet, a wardrobe (119 m²)

the common family villa also has a separate cellar space with an area of 27.6 m²






