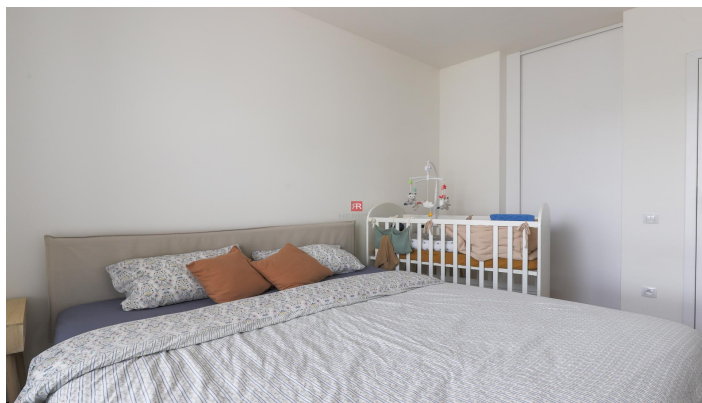

LOCALITY

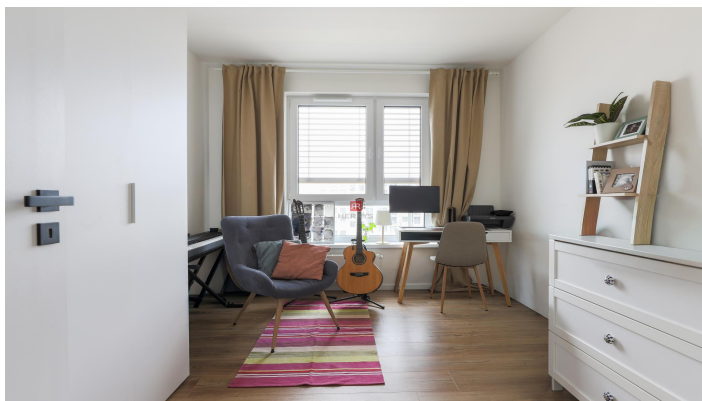
