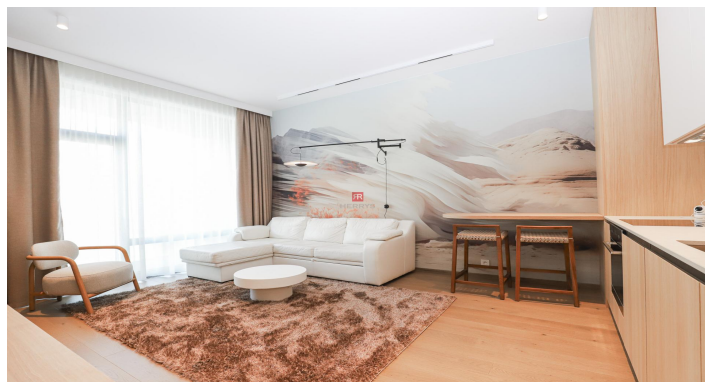

LOCALITY

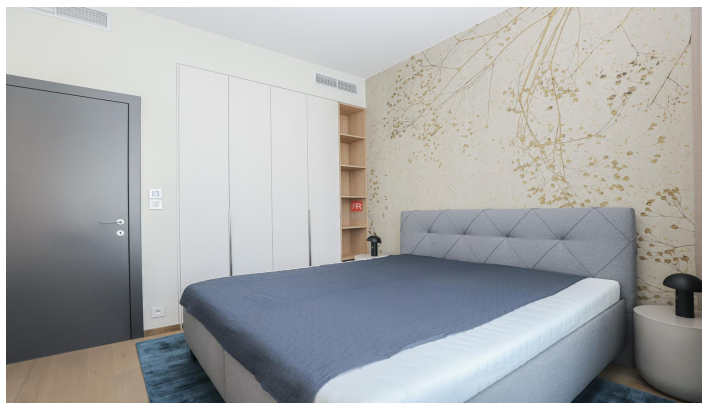
