The apartment includes **1 parking space in the underground garage, which is accessible by dry foot, and 2 brick cellars (total area 8.22 m2) directly below the apartment.** The entrance height of the garages is above standard 2.5 meters and allows comfortable entry of a vehicle even with a roof box. An elevator leads from the garage directly to the first floor, to the entrance door of the apartment.

## DISPOSITION

The apartment consists of an entrance hall, a living room connected to the kitchen, 2 bedrooms and 2 bathrooms. The living room has a practical, remote-controlled, maintenance-free gas fireplace, which is connected to the central distribution. The elegant sofa is a sofa bed and provides comfortable beds for 2 more people. From the living room there is an entrance to the terrace with a picturesque view of the tree line of the Tatra National Park, surrounded by a small mountain stream. Both bedrooms have separate bathrooms with a bathtub/shower, the designer sanitary ware is of the premium brand Villeroy & Boch. The bedrooms have high-quality beds from the Saffron brand.

## LOCALITY

- Tatranská Lomnica is a great starting point for hiking.
- You can go to Skalnaté pleso, Lomnický štít, Zelené pleso and many other places. For example, a tour of Skalnaté pleso, a visit to Skalnaté chata, but also a unique view from Lomnický sedlo are attractive.
- In winter, you can ski on the longest slope in Slovakia, or on the highest one located directly below Lomnický štít. However, children and beginner skiers will also have their fun.
- Close to the Black Stork golf course.
