It has undergone partial reconstruction – the windows have been replaced, the roof and two sides of the facade have been insulated, the wiring has been partially replaced, and a new gas boiler has been installed, which provides heating and hot water.

The first floor has been completely renovated and designed with an emphasis on style and functionality.

The second floor offers space to finish according to your own ideas – it has undergone partial renovation.

On the ground floor, there are two rooms that can be used as a laundry room or cellar and a practical garage for one car.

The 725 m<sup>2</sup> plot is flat, with a well-maintained garden, greenhouse, and private well.
