Thanks to the roof, the terrace can be used throughout the year – in the summer months as an outdoor living area, in winter as a relaxing wellness area.

The layout of both floors was designed **with the needs of families with children in mind**. On the lower floor, there is a practical space under the staircase that serves as a mini playroom with storage space for toys. The main playroom is located on the open upper floor, where a net is attached between the beams, giving the space an airy feel and remaining visually connected to the lower floor.

A striking design feature of the entire interior is **the black metal staircase with railings**, complemented by solid oak steps that emphasize the industrial character of the apartment.

The apartment is located **on the 5th and 6th floors of a brick apartment building without an elevator on Legionárska Street**.

The location offers true city living - everything you need is at your fingertips, from cafes and services to quick connections to the city center, while maintaining a pleasant balance between city bustle and peace for everyday living.

- The apartment underwent a complete renovation and modernization in 2021, including the replacement of all utilities (gas, electricity, heating).
- The apartment building dates back to 1923, with the attic conversion completed in 2000.

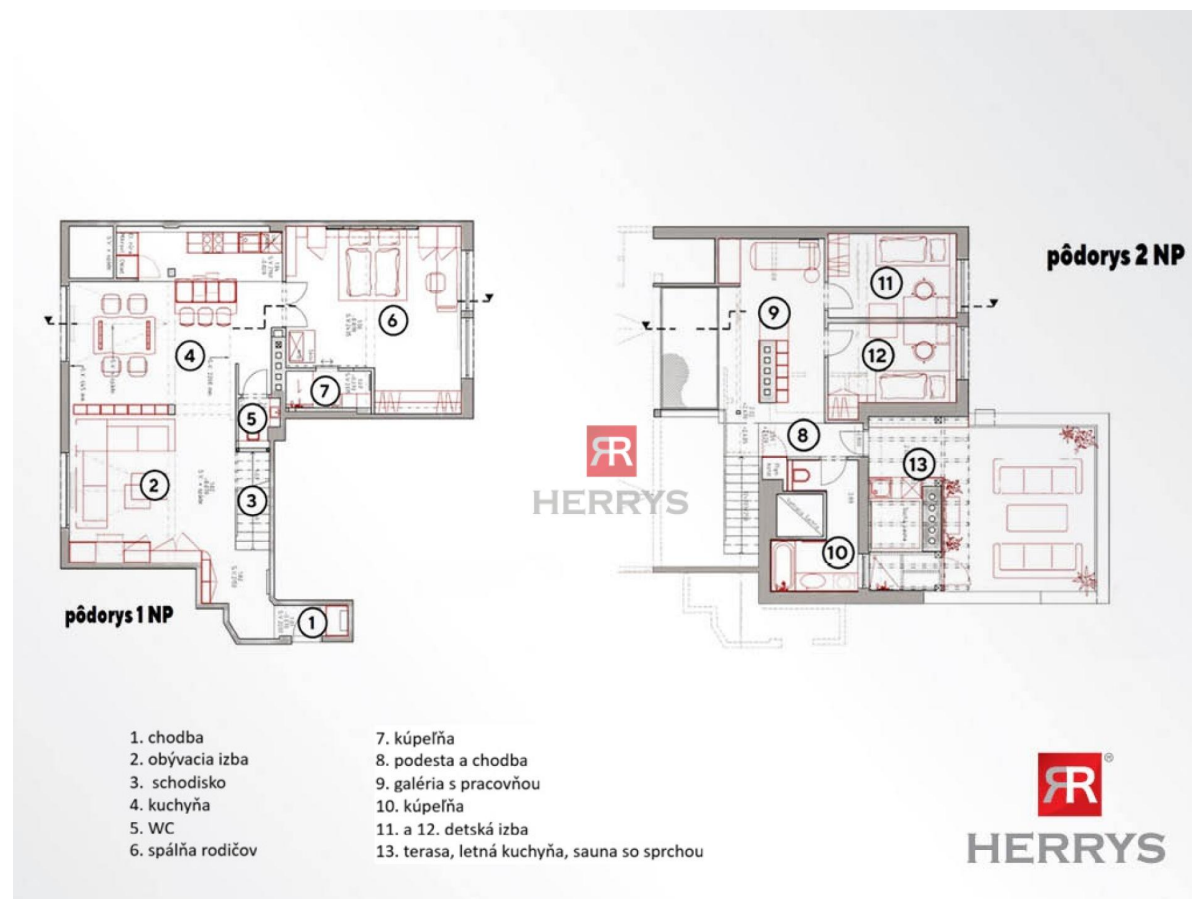

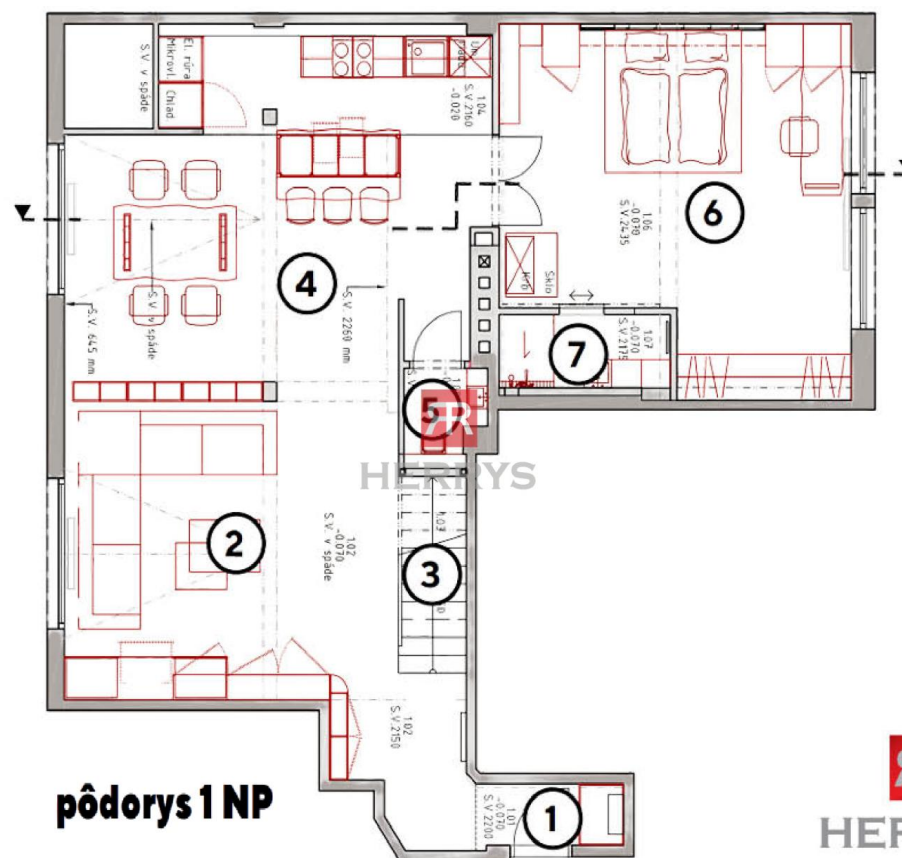

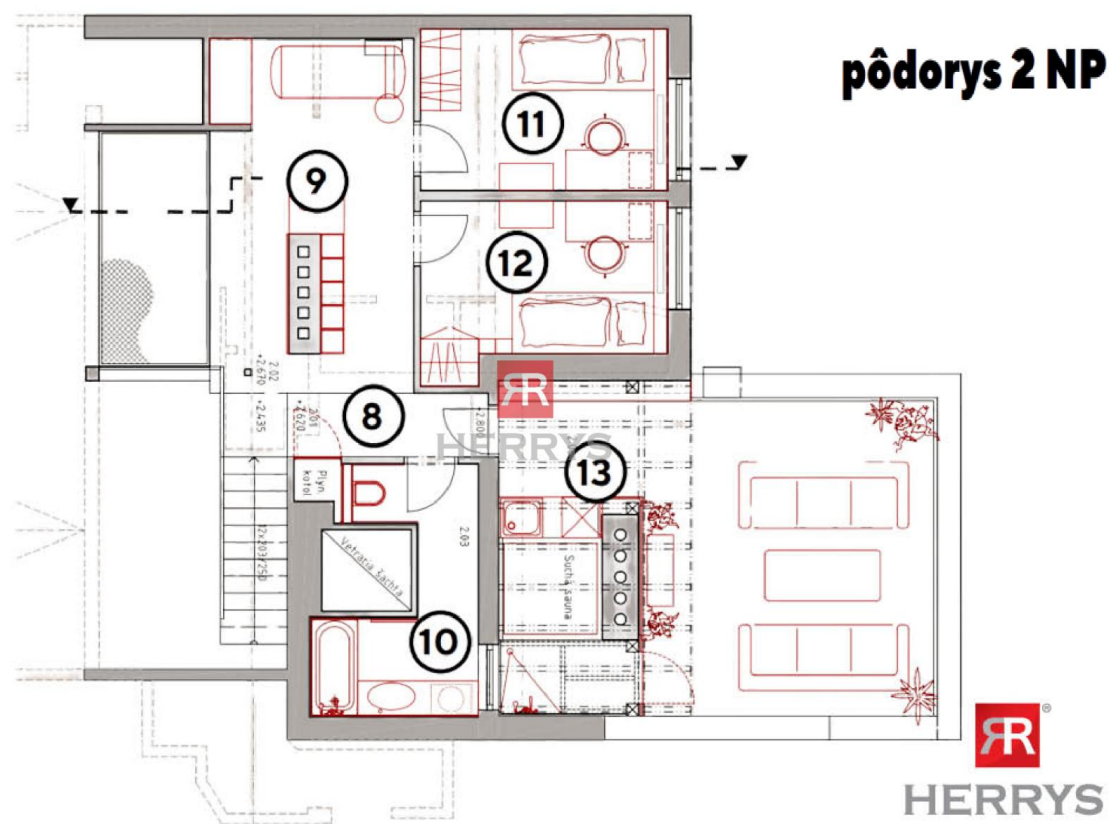
