The comfort of living is increased by air conditioning, blackout curtains and passive heat recovery in each room. Bedroom provides pleasant privacy with sufficient space thanks to built-in wardrobes. There is a direct access to a generous loggia from both the living room and the bedroom.

Kitchen is equipped with high-quality built-in appliances (electric hob, electric oven, extractor hood, dishwasher, fridge/freezer). Windows are plastic with insulating triple glazing. Flat has large-format vinyl + cork parquet floors, and the bathroom and toilet have ceramic tiles.

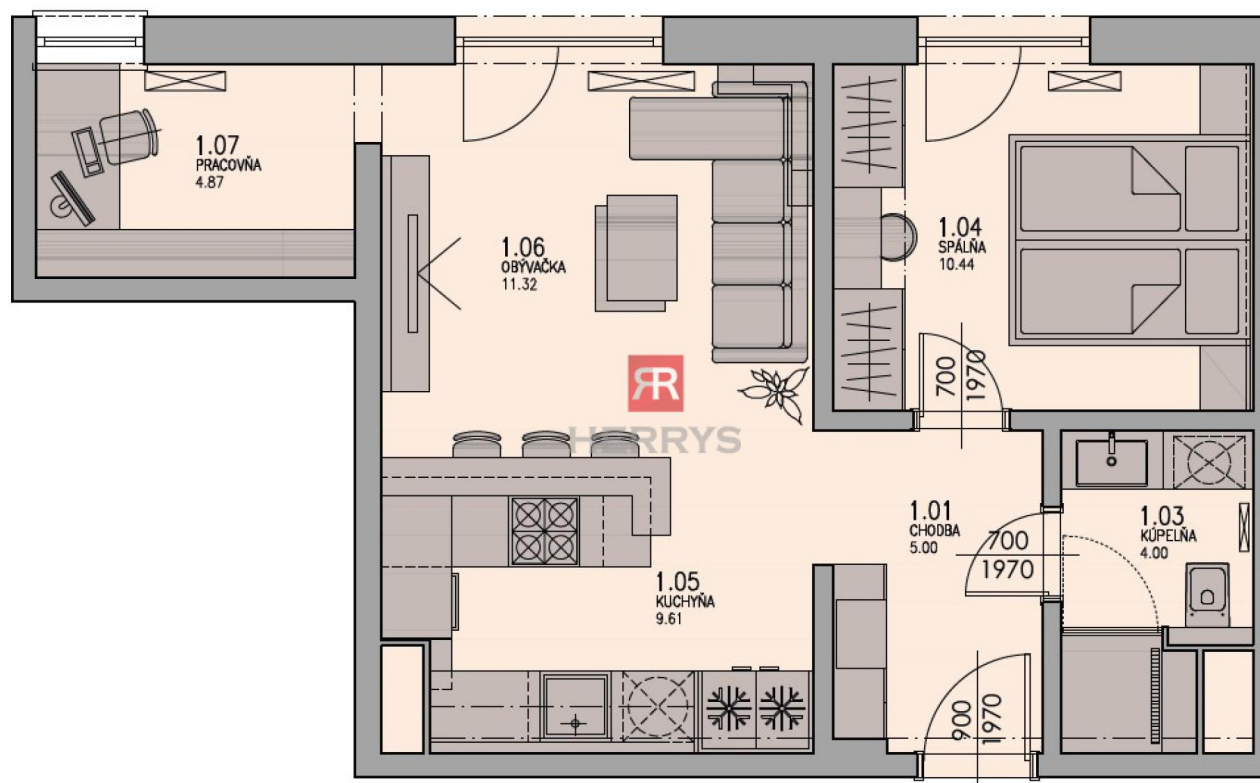
