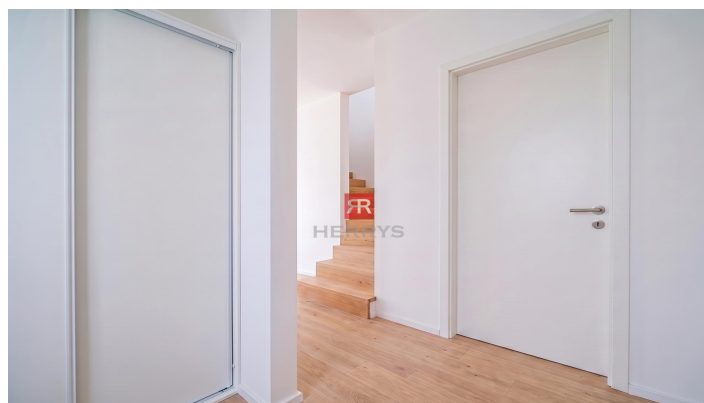
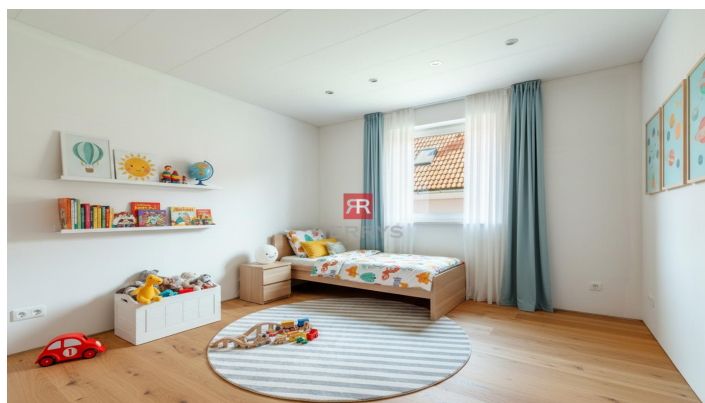

The house includes a front yard and two designated outdoor parking spaces. Heating is provided by underfloor heating (powered by an electric boiler with a hot water tank); the house will be pre-wired for air conditioning and outdoor electric blinds.

The single-family home is being sold as a shell with the option of turnkey completion (+ €15,000). The expected occupancy permit is September 2026.

The home is part of the new "Ľudové domy" project in Vajnory, which consists of 6 separate units (3- and 4-room units).

The house has two stories; the ground floor features an entryway, a separate restroom, and a living room with a kitchen and dining area, while the second floor has two separate bedrooms, a bathroom, and a closet.

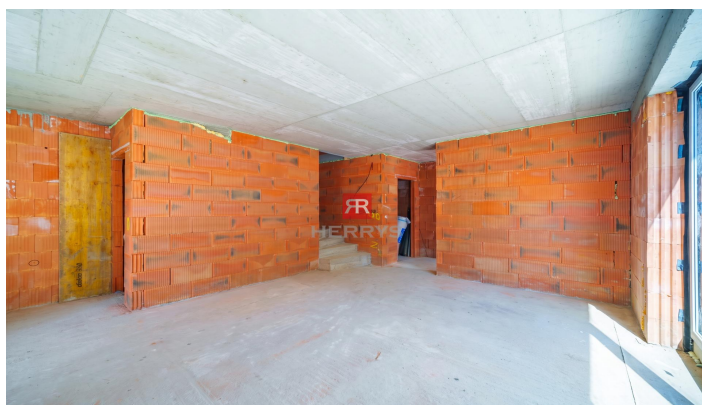
