DISPOSITION

Apartment consists of a hallway, from which you enter the spacious living room with an eastern orientation and beautiful views of the historic center of Bratislava. 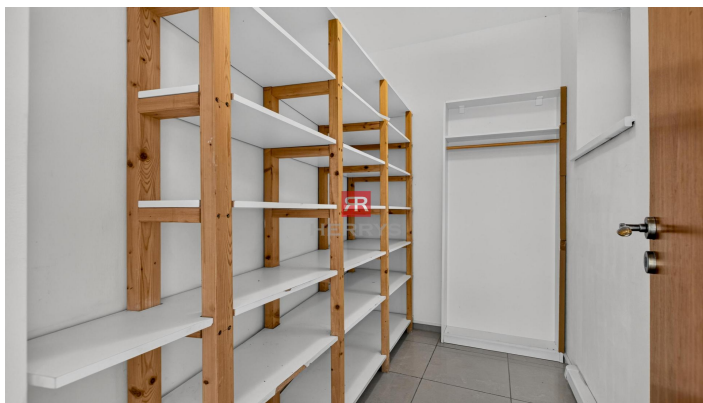
Location also offers excellent transport connections to all parts of the city, public transport stops are just a stone's throw away.

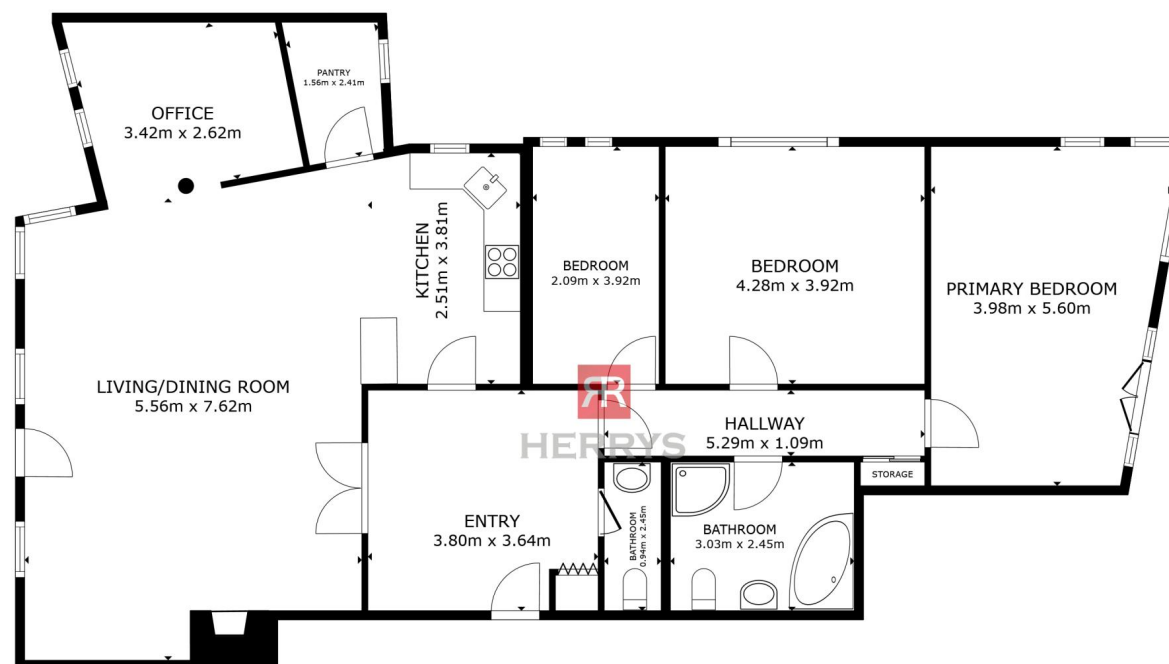
