

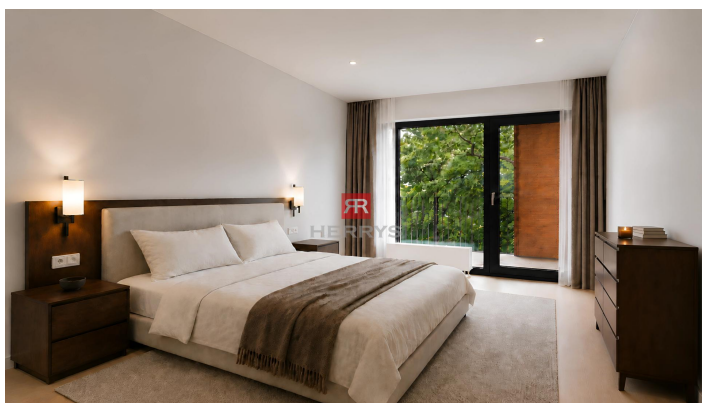

Technical specifications:

The interior features **gypsum plaster with white paint**, while the floors are prepared with cement screeds. The final flooring finishes can therefore be selected by the owner according to their preferred design.

Comfort is enhanced by **high-quality PVC windows with insulating triple glazing**, contributing to both thermal and acoustic comfort. External shading is provided by a mechanically operated sliding louvre system covering part of the loggia.

Security is ensured by **Class 2 security entrance doors**. Interior doors are not included in the standard specification, allowing the future owner to select them according to their own preferences.

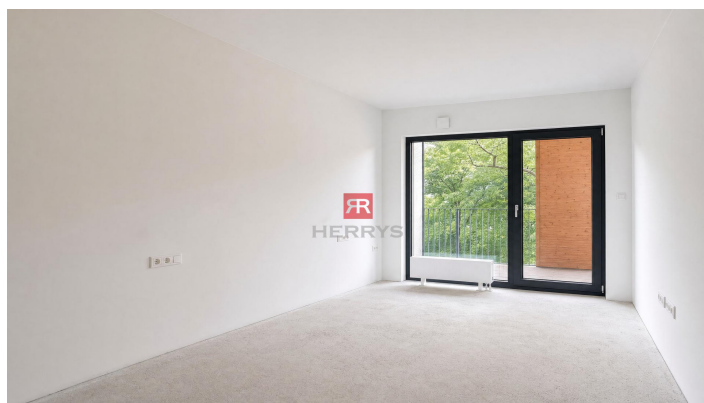

Heating is provided by a **central boiler room** with radiators and individual heat metering for each apartment. The bathroom is prepared for the installation of a washbasin and wall-hung WC, as well as a bathtub or shower enclosure.

The technical specification also includes **preparation for air conditioning**, specifically an electrical connection for the installation of an external air-conditioning unit on the loggia or terrace. The apartment is also equipped with preparation for a kitchen extractor hood and an exhaust fan in the sanitary areas.
